



Deed of SARDARNI JOGINDER KAUR HAYER MEMORIAL EDUCATION TRUST J SHAHABAD MARKANDA

This indenture is made on this the daday of Jone 2006 by Dr. Gurdip Singh Hayer S/o S. Kartar Singh Hayer, Hayer Farms, Ladwa Road, Shishabad (M), Distr. Kurukshetra herein after called the Executor Trustee / Settler (which expression shall unless excluded by the repentant to the subject or content the docted to include their higher, executors, administrator and representatives).

Whereas the settler is desirous of creating an endowment by setting apart and establishing a fund for the charitable trust and purposes hereinafter expressed. The trustees have at the request of settler agreed to act as trustees of these presents upon the terms and provisions herein after contained.

AND WHEREAS the settler doesn it expendient to reduce the aims and objects as well as the rules and regulation to writing.

Now, therefore this deed witnessed as under :

- 1. In order to effectuate the said object of creating and establishing a charitable trust for public the settlier has delivered to and made over to the trustoes a sum of Rs. 11000/- (Rs. eleven thousand only) with intent to part with all the rights, title, interest and claim therein and vest the same in the Trustoes to have and to hold the same and the investment or investments for the time being representing the same and all other properties that may for the time being represent the trust estate together with all additions and accretions thereto and all accumulated income thereof and all other property or properties that may be required out of the same or otherwise may hereafter be subject to the trust (hereinafter referred to as "The Trust Fund") for the charitable objects and purposes and uses hereinafter expressed with the powers and on the terms and conditions herein contained of or concerning the same.
- Name: The trust shall be called "SARDARNI JOGINDER KAUR HAYER MEMORIAL EDUCATION TRUST SHABABAD MARKANDA"
